

PRIVACY POLICY

The privacy and confidentiality of user information is important to MSLA ID, S.L. We are committed to the privacy and security of user information.

This Privacy Policy is intended to help you understand:

- Identify who is responsible for processing your data;
- What regulations apply;
- what personal information we collect about you;
- how we use, disclose, and protect your personal information;
- with whom we may share your personal data;
- how you can update, manage, export, and delete your information;
- how long we keep your personal data;
- what your rights are in relation to personal data protection;
- how you can contact us to learn more about our privacy practices.

1.- PERSON RESPONSIBLE FOR THE PROCESSING OF PERSONAL DATA

In terms of data protection, MSLA ID, S.L. shall be considered the Data Controller with regard to the personal data collected and data processing activities carried out through this website or through any other means, such as by telephone, email, in person, on paper through forms, through legal documents, etc., whose identification details are as follows:

MSLA ID, S.L. has appointed a Data Protection Officer in compliance with the provisions of Regulation (EU) 2016/679 and other applicable regulations.

2.- REGULATIONS

MSLA ID, S.L. undertakes to protect the privacy of the owners of personal data in accordance with current regulations (Regulation (EU) 2016/679 of the European Parliament and of the Council of April 27, 2016, on the protection of natural persons with regard to the processing of personal data and on

the free movement of such data, and repealing Directive 95/46/EC) and Organic Law 3/2018, of December 5, on Personal Data Protection and Guarantee of Digital Rights.

3.- INFORMATION WE COLLECT ABOUT YOU

3.1. Contact form.

We may collect the following information when you make an enquiry through the website:

- Name and last names .
- Company name.
- Job title.
- Country
- Business email address.
- Contact telephone number.

The legal basis for this processing is the express consent given by the user when accepting the website's privacy policy.

The purpose of processing your personal data is to manage the query made.

This personal data will be kept for as long as the purpose for which it was collected remains valid and until you revoke your consent to the processing of your data.

3.2. Registration and login.

We may collect the following information when you register or log in through the website:

- Email address.
- Phone number.

The purpose of processing your personal data will be to provide the service agreed upon.

This personal data will be kept for as long as the purpose for which it was collected remains valid and until you revoke your consent to the processing of your data.

4.- MINORS

Minors may not use the services offered through the website without the prior authorization of their parents, guardians, or legal representatives, who will be solely responsible for all acts carried out through the website by minors in their care, including filling out forms with the personal data of said minors and checking the accompanying boxes, where applicable.

5.- SECURITY

MSLA ID, S.L. strives to protect the security of your personal information and your choices regarding its intended use.

The information shared is stored on a secure server and we use procedures designed to protect the personal information we collect from unauthorized access, destruction, use, modification, or disclosure.

Although we will take (and require our third-party service providers to take) commercially reasonable security precautions with respect to your personal information collected and stored on the Site, due to the open nature of the internet, we cannot guarantee that any of your personal information stored on our servers, or transmitted from a user, will be free from unauthorized access, and we disclaim any liability for any theft or loss, unauthorized access or damage, or interception of any data or communication.

6.- COMMUNICATIONS TO THIRD PARTIES

MSLA ID, S.L. does not sell or lease your personal data to third parties and will only disclose it to persons or entities if we obtain your prior consent or in compliance with or in accordance with applicable law when such consent is not necessary for a specific transfer. We will share or give access to those service providers used by MSLA ID, S.L., necessary for the purposes described in this Privacy Policy, always complying with the requirements established by current legislation.

Your personal data may be communicated to the following third parties:

- State Security Forces and Bodies. They will be sent the information strictly necessary for the fulfillment of the legal obligations of the Data Controller.

Your personal data may be communicated to the parent company of the group, located outside the European Economic Area (EEA), exclusively for internal administrative purposes or for the proper provision of the services contracted through this website. Such communication is carried out with the appropriate guarantees required by applicable data protection regulations, in particular through the signing of standard contractual clauses approved by the European Commission that ensure a level of protection equivalent to that of the EEA.

7.- INTERNATIONAL DATA TRANSFERS.

In some cases, the personal data we collect may be transferred and processed in countries outside the European Economic Area (EEA). These transfers will only be made when necessary for the fulfillment of our contractual obligations to you, the operation of our services, or with your explicit consent.

We ensure that all international transfers of personal data are carried out in accordance with applicable data protection legislation. This includes the implementation of **appropriate safeguards**, such as:

- The signing of **standard contractual clauses** adopted by the European Commission.

- Transfer to countries that have an **adequacy decision** from the European Commission.
- Other measures that guarantee a level of personal data protection equivalent to that established by the GDPR or other applicable local regulations.

Users may request further information about international transfers and obtain a copy of the appropriate safeguards by contacting us through the channels indicated in this policy.

8.- DURATION OF PROCESSING

We will keep your personal information for as long as necessary to fulfill the purposes for which it was collected, unless you request its deletion or object to the processing of your data.

In any case, we will keep your data for as long as we are required to do so in compliance with a legal obligation.

9.- EXERCISE OF RIGHTS

As the owner of your personal data, you may exercise the following rights at any time:

- **Right to withdraw consent** given;
- **Right of access** to the information we process about you;
- **Right to rectify** your data, if it is inaccurate or incomplete;
- **Right to erasure**, when, among other reasons, your data is no longer necessary for the purposes for which it was collected;
- **Right to object to the processing** of your data in certain circumstances, for example, direct marketing, including profiling;
- **Right to restriction of processing**: you have the right to request the restriction of the processing of your data in the cases established by law. Likewise, the data controller may restrict processing when the user contests the accuracy of the personal data, for the period enabling the controller to verify the accuracy of the data; or when the user objects to the processing, while it is being verified whether it is appropriate.
- **Right to data portability**: you have the right to move, copy, or transfer the data you have provided to us in a structured, commonly used, and machine-readable format from our database to another. You can only exercise this right with regard to the data you have provided, when the processing is based on the execution of an agreement or on your consent, and the processing is carried out by automated means.
- **Right to lodge a complaint with the Spanish Data Protection Agency** if you consider that the processing does not comply with current regulations.

To do so, you must send a written request, indicating the right you are exercising, your name and surname(s), address for notification purposes, together with a copy of your ID card or other valid document proving your identity, to:
